- 1. Opening Business:
- 1.1 Board member sign in completed
- 1.2 Agenda added 3.1 PST charges, and 5.3 Seedy Saturday

- **3. Treasurer's report** Treasurer notes a small loss in 2015 due to a variety of factors (no TAP in operation for several months, no bulk fruit purchase, reduction in cider press rentals, etc.)
- **3.1 PST charges for Cider Press Rentals** this should have been charged. Overall cost would be approx. \$15.40. Board discusses absorbing these costs now and going forward. Unanimous agreement.

- **5.3 Seedy Saturday** Discussion over display it is clear Skookum needs a better display. The new board should make this a priority. Edward reports there was some discussion by attendees regarding

Ecossentials – some negative. There seems to be some confusion over Skookum's role in the possible creation of a local Co-op and involvement with Ecossentials. Overall Seedy Saturday was not as busy as in past.
