

# Memorandum of Association

## 1. Full name of Association: Skookum Food Provisioners' Cooperative

## 2. Purpose of Association

The purpose of the Association is to

- 1) help its members acquire and share the knowledge, skills, and resources they need in order to
  - a) grow, gather, raise, and catch healthful food as locally as possible;
  - b) preserve, store, prepare, and share the bounty;
- 2) build a strong community and a diverse local food economy based on mutual support, fair prices, living wages, and respect for the natural systems which sustain life.

## 3. Community service cooperative

The Association is a community service cooperative. This provision may not be altered.

## 4. Restrictions on business

There are no restrictions on the business of the Association.

## 5. Authorized share capital

Membership shares have a par value of \$20.00 CDN. The Association may issue an unlimited number of membership shares.

## 6. Liability

The liability of a member of the Association is limited in accordance with the *Cooperative Association Act*.

## 7. Dissolution

Section 178.1 (4) of the *Cooperative Association Act* applies to the Association. This provision may not be altered.

## 8. Subscribers
